# **POLICIES OF IAVAT**

- 1. The primary purpose of IAVAT shall be for professional reasons and not for gain of individual members.
- 2. All committees, officers, members and others concerned with furthering agricultural education may submit a written copy of their resolution to the Special Projects and Resolutions as resolutions are developed.
- 3. Policies will be printed in the committee report each year and posted on the IAVAT web site.
- 4. Reports accepted by the membership at the annual meeting shall be forwarded to the Board of Directors for their action.
- 5. The Board of Directors shall be prepared to testify before legislators and any public hearing. Statistics, information, viewpoints, or philosophies should be reviewed by the President and/or Executive Director and discussed by the members of the Board of Directors prior to any official testament. Any member of the Board of Directors or IAVAT member may testify without clearance, provided IAVAT stationery is not used or the member states they are testifying as an individual and are not representing IAVAT.
- 6. The Board of Directors, through the Advocacy Committee, shall study pending legislative bills and notify membership of IAVAT "stands" on the issues.
- 7. Members elected to the Board of Directors shall be prepared to attend NAAE Convention and Summer Regional Conference. Approval from the local school administration should be obtained prior to election to major office.
- 8. Representation to the Illinois Association for Career and Technical Education Board of Directors shall be designated annually by the IAVAT Board of Directors.
- 9. The most recent Past President shall serve as chair of the Nomination Committee.
- 10. The fiscal year for auditing purposes is considered to be July 1 to June 30. The membership year is considered to be July 1 to June 30.
- 11. The reimbursement form for the expenses of the members of the Board of Directors are approved and signed by the President.
- 12. Convention and conference expenses of the Board of Directors incurred to attend the NAAE Convention and NAAE Summer Regional Conference are paid by IAVAT as listed in Policy 14 and based on equivalent cost of sending allowable voting delegates.
- 13. Members of the Board of Directors will receive be reimbursed for expenses incurred while attending approved conferences, conventions and other assigned duties at the following rate: mileage at twenty-three (23) cents per mile, unless public transportation is cheaper and convenient; meals at \$18.00 per day; lodging at single rate or 50% of double room rate; parking at actual cost; all expenses actual cost up to maximum allowed. Should the combined expenses of the Board of Directors exceed the budgeted amount; the expense reimbursement will be prorated.
- 14. By agreement with Region IV delegate body attending the Summer Conference in Michigan in 1971 the expenses of any State Association President invited as a guest to any other Annual Agriculture Teachers Conference in Region IV will be paid by that president's own state organization.
- 15. Career Development Events (CDE's) sponsored by and under the jurisdiction of the IAVAT are: Ag Business Management, Agriculture Sales, Agronomy, Horticulture, Dairy Foods, Dairy Cattle, Forestry, Livestock, Meats Evaluation & Technology, and Poultry. All other contests will be under the jurisdiction of the FFA Board of Directors.
- 16. Section boundaries shall be reviewed every five years by the IAVAT Board of Directors.
- 17. The President shall appoint members to standing committees after recommendations from the District Directors and the Section Chairs.
- 18. Committees working for IAVAT are encouraged to use their own funds to complete their assignments. The Board of Directors must approve exceptions.
- 19. IAVAT committees shall meet no less than three times per year. One of the three required IAVAT committee meetings per year can be by mail or e-mail for review of documents or voting on committee work, as long as a committee participation report is submitted.
- 20. Members of IAVAT committees must attend a minimum of two committee meetings per year in order to retain their seat on the committee.
- 21. IAVAT committees shall annually submit an attendance report showing each meeting, the date of the meeting and the record for each committee member.

- 22. The retiring President will receive a plaque presented at the annual banquet by the past president or their appointee. All other retiring officers of IAVAT will receive a token of appreciation at the annual IAVAT conference, presented by their successor.
- 23. Teacher Mentors attending the IAVAT Awards Banquet, who are not registered for the IAVAT Conference as an active member, will be provided a complimentary banquet ticket.
- 24. Persons who contribute to the advancement of IAVAT may receive the Certificate of Merit and/or Life Membership. Individuals nominated for these recognitions shall be selected and approved by the IAVAT Board of Directors at the spring board meeting and presented during the annual banquet.
- 25. Once accepted by the Board of Directors, the Supporting Associate member does not need to reapply for membership.
- 26. Payment and refund of Association dues:
  - A. It is recommended that Association dues be paid at the sectional meetings during the annual IAVAT conference in June.
  - B. Dues may be paid in total with one check or in a series of post-dated checks presented at one time, with a maximum of six (6) checks for first year teachers, four (4) checks for experienced teachers, with last check dated December 1.
  - C. Dues may be accepted at any time; however, any member whose dues are unpaid, either in whole or in part after October 31, shall not be in good standing until such dues are paid.
  - D. First year teachers shall be assessed one-half of current IAVAT dues plus current full dues of NAAE rounded to the nearest dollar. The new teacher entering the school system the second semester or later will be assessed one-quarter of current IAVAT dues plus current full dues of NAAE and IACTE rounded to the nearest dollar. ACTE and Agriculture Education magazine may be in addition to both options.
  - E. No refunds can be provided for affiliated organizations (IACTE, ACTE and NAAE) once these dues have been forwarded.
  - F. If a member dies within the first semester, one hundred percent of the IAVAT Association dues will be voluntarily refunded to the widow or family. If death occurs in the second semester, fifty percent of the IAVAT Association dues will be refunded.
  - G. If an individual leaves the profession of teaching agricultural education in Illinois and has paid their dues, they will be refunded one hundred percent of the IAVAT Association dues if they leave before October 31. If the individual leaves between November 1 and February 1, they will be entitled to a fifty-percent refund on IAVAT Association dues. If an individual leaves the profession after February 1, they will not be entitled to a refund.
  - H. To be eligible for a refund, notice must be made to the Association in writing to the Executive Director.
  - I. All benefits of, by, for, and through the Illinois Association Vocational Agriculture Teachers shall immediately cease upon termination of membership in the Association.
  - J. Sections with ninety-percent IAVAT membership and above will be recognized at the IAVAT Conference.
- 27. Community or Junior College teachers may be active members by paying all dues or become Associate members of IAVAT upon payment of all affiliation dues and support dues to IAVAT as determined by IACCAI at their annual conference. Upon payment of active IAVAT dues by community college and/or Junior College instructors the IAVAT will reimburse the IACCAI the amount of IACCAI dues.
- 28. In order to maintain their eligibility for IAVAT Service Awards, all Active, Associate, Retired, and Life IAVAT members must maintain membership in NAAE as well as IAVAT.
- 29. Any person serving the ex-officio capacity of IAVAT is interpreted to imply: that person has the right to serve on committee with voting rights on committee matters, but **does not** give that person voting privileges in the annual meeting or executive committee meetings.
- 30. Any person or organization making payment by check to the IAVAT for any obligation (ex: dues, CDE or conference registration) will be charged a \$20 penalty if such payment is uncollectible for any reason. The individual or organization will be considered "not in good standing" until the original obligation and penalty are paid in full by certified check or money order.

They will work collaboratively with and in support of volunteers, other development staff, and other FFA staff to cultivate and solicit donors for Foundation priorities. The 2015 Illinois Foundation FFA final collection is **\$521,962.16**, which surpasses the 2015 goal of \$500,000.00. Many, many thanks to all of you for assisting in the Illinois Foundation FFA reaching their goal and more.
- Empowering You, our teachers I want to find ways to lighten your load, brighten your day and help you know, feel and believe just how impactful you are. #### Find a Better Way

It has not quite been a year since joining the FFA Center Team and with 10 months under my belt I still feel like a Greenhand. The Illinois FFA Alumni Council - is a tremendous group of volunteers, truly committed to serving the Illinois FFA members. They are dedicated leaders who serve you at both the state and national levels. Richard DeSchepper serves as the Illinois FFA Alumni Council President. Currently we have two from the Alumni Council on the National FFA Alumni Council: Ron Lynch, District II Director & National FFA Alumni President-Elect; and Ted Hughes, District V Director & National FFA Alumni Region IV Vice President. They are both traveling the Nation serving agricultural education and are eager to find ways to better serve you and your students.

The Alumni will have their annual conference and auction January 27-28, 2017. The money raised from the auction goes towards Alumni Scholarships for FFA members. The Alumni gives out scholarships for three different leadership conferences: The 212 Conference, Washington Leadership Conference, and FFA Leadership Camp. In 2017, the auction will be held on Friday night after the banquet, this will open up Saturday for roundtable discussions and alumni chapter building.

The Alumni Membership increased from 8,068 to 17,572 due to the Affiliate Fee Program. The Affiliate Fee Program is a flat yearly fee of \$150 or \$50 (if the chapter has 25 or more lifetime members), this leaves more money locally. It's a great way to get more people involved in your alumni chapter.

We also do the annual Gator Raffle and the FFA Chapters/Alumni Affiliates selling raffle tickets will receive 40% back of their total sales, and the FFA Chapter selling the winning ticket will receive \$300. The money raised goes towards the alumni scholarships given throughout the year. We will also be having a Gun Raffle this year which will be announced in July/August.

The Alumni also sells merchandise at the FFA Convention, and sponsors the FFA Dance, providing soda, water, and ice cream. The left over soda and water will be used on the FFA Bus to Washington Leadership Conference.

I encourage you to share your thought and ideas with any of our Alumni Council members. If the Illinois FFA Alumni can serve you and your members through ways other than or beyond scholarships to leadership events, let us know. We are open for suggestions.

### Year in Review Harley Hepner, Principal Consultant, Illinois State Board of Education

Reflecting over the past fiscal year (FY 2016), the state grants funded through the Agricultural Education line item helped to implement initiatives supported by ISBE and ICAE/ILCAE. The Agricultural Education line item was level funded at \$1,800,000 and funded the following grants in FY16: FCAE (\$1,085,365), IFG (\$616,635), and GAST (\$98,000). Career and Technical Education's line item was level funded which supports the CTEI grant. The Career & Technical Student Organizations (CTSO) grant to the Illinois Association FFA saw an increase (FY16 - \$45,911) due to unobligated funds, but the increase is not likely to carry over into future years. Despite the lack of a budget for most of state government in FY16, the portion of the ISBE budget that flows to local districts was appropriated last July and funds have been flowing without delay at near normal timeframes. While the line item, generally, has support within the agency as evidence by the recommendation to increase the line to \$3.0M, those supporting the line item must still be vigilant in their support given the state's financial position because future erosion may cause elimination of grants and related services in the line item. Continue to engage your elected officials in sharing your perspective. Thank you to individuals who worked behind the scenes, local teachers and individuals, as well as other advocates who acted on behalf of and voiced their support in favor of the line item.

There were other legislative topics this year that have potential for impact. As this is written, there seems to be broad support for legislation (SB2975) supporting a framework for funding to assist instructors and districts financially supporting the extra time instructors invest. This legislation that seems likely to pass in both legislative bodies also instructs Agricultural Education be identified as a teacher shortage area in Illinois which is intended to open opportunities for teachers to gain access to resources such as loan forgiveness. HB5729 is legislation originating from the recommendations from HR477 (2015) that address changes to Career and Technical Education impacting Agricultural Education. This legislation also appears to have broad support in both legislative bodies and, if signed into law, will initiate reforms such as defining career experiences students have in middle and high school, providing a comprehensive framework for all students pursuing college and career pathway endorsements, requiring individualized career plans, professional learning challenges and internships, competency based high school graduation requirements, integration of academic and career competencies, 12<sup>th</sup> grade transitional courses targeting math remediation, establishing grade level expectations (8-12) for college and career exploration, financial aid and literacy, and reinforces the need for programs to articulation with postsecondary institutions strengthening the connection.

The State continues to consider performance measures related to line items when making funding decisions meaning we need to have data to support how programs are impacting students. While Agricultural Education continues to be a good example with data supporting the work that is done, in the future, we may need to show more of a specific impact on students in the classroom and on those underserved populations especially when it comes to access and equity (diversity). We need to assist more diverse populations by creating an environment and activities in our programs welcoming to those of diverse backgrounds.

State leaders in Agricultural Education continue to explore additional options to support initiatives in Agricultural Education. In FY16 (\$55,600) the Agriculture, Food, & Natural Resources (AFNR) STEM Learning Exchange (LE) continued to provide additional opportunities to further develop and enhance the Agricultural Education model in Illinois with special focus on Supervised Agricultural Experience (SAE) data and growth. With only partial aggregate student data collected statewide, SAEs make a big impact of nearly \$12M in Illinois. The STEM LE project future is uncertain at this time. Grant funds should also be available to your programs through the Perkins and Career and Technical Education Improvement (CTEI) grants handled through you Education for Employment (EFE) office. Please contact your EFE System Director for more specific information on how to access funds for equipment, supplies/materials, and professional development opportunities. Finally, ILCAE has worked toward identifying other potential support and has included new business and industry partnerships in support of Agricultural Education.

Agricultural Education was able to continue making an impact in schools across Illinois K-adult largely through the efforts of the teachers, the FFA Center staff, and the FCAE staff and partnerships with other groups. There were seven new or re-starting agricultural education programs (public and non-public) around the state in FY16 as we continue to explore ways to increase the footprint on student impact in Illinois. We continue to grow the number of programs in Illinois, but are concerned with attracting and retaining quality teachers to fill open positions. The National STAR program has conducted a number of activities to address

the issue as resources are available. The university programs will be working to support newly graduated teachers in the classroom this coming year. This issue continues to be a topic of discussion at ICAE and ILCAE meetings in how best to address. While there is no one magic bullet to address teacher recruitment and retention related issues, various actions have been taken, some referenced above, to increase awareness provide resources and support to assist potential and current teachers.

While Agricultural Education is leading several efforts to increase the awareness and interest in Agricultural Education as a profession, one of those efforts includes the Growing Agriculture Science Teachers (GAST) grant focusing on the recruitment and development of quality agricultural teachers. The purpose of this grant initiative was to recruit, train, and retain agricultural science teachers. The grant is available to all universities and community colleges in Illinois who offer agricultural education. This is now a continuation grant in its second year (FY16) where the following applicants awarded \$14,000: Illinois State University, Southern Illinois University, Western Illinois University, University of Illinois, Black Hawk East College, Joliet Junior College, and Lake Land College. The grant funds activities targeting a segment of the agricultural education continuum from grade 11-16+ as well as newly certified agriculture teachers in their first five years of teaching. While applicants could propose a variety of activities, the main focus remains on recruitment through internship related programs. Other activities included scholarships, student teacher assistance, recruitment events, as well as professional development activities.

Initiatives at the Illinois State Board of Education continue to evolve. The grants administered by ISBE are now all online in IWAS. There were several legislated changes through the Grant Accountability and Transparency Act (GATA) that will impact grants beginning in FY17 including districts needing to prequalify for grants and complete a risk assessment prior to award of funds. This is likely to have the most impact at the administrative level at the district – not instructor level. In 2018, a separate license will be required to teach at the middle school level with those currently appropriately licensed grandfathered in and others needing to take coursework to get their middle school endorsement. In trying to work with our licensure division, it appears that we may not be moving toward a K-12 license and toward a narrower grade band such as 6-12, but progress appears to be slow. The framework and alignment of the content test was also reviewed this year. The agency also saw several additional changes in personnel at the top.

ISBE continues to support the development and enhancement of Programs of Study (POS). A full POS helps students see the path to a specific career by outlining academic and technical courses, identifying work based learning experiences, offering articulated or dual credit courses, involving students in real work situations where they apply their knowledge, and providing industry recognized and valued credentials or certificates - all working together to assist a student in advancing towards a desired career. While 30-40% of agriculture programs have either an articulation or dual credit agreement with their community college, we need to work at a local level to develop additional agreements.

Thank you for the opportunity to serve you this year. I also want to express a sincere appreciation to the FCAE staff, the State FFA Center staff and many others in Agricultural Education who work very hard to make improvements on your behalf. It is an honor and a pleasure to represent the Agricultural Education family of professionals. Continue to be involved in the profession so as to build your own future. Please keep in contact with me sharing your needs in the classroom and your ideas on how to move Agricultural Education forward in Illinois. As a professional, what you do in the classroom is very important. I hope you are proud to be an agriculture teacher and of the work that you do. Congratulations on your successes and thank you for your commitment to students, your profession, your schools and communities.

# ILCAE

ILCAE believes that the Illinois Agricultural Education Line Item represents an important investment in both our youth and industry. It provides a fantastic rate of return. ILCAE also recognizes, however, that the future of agriculture in Illinois will demand greater investment. Only four percent of secondary students take an agriculture course despite the fact that one in four jobs in Illinois come directly or indirectly from agriculture. This is terrible for industry. Solving the problem will require novel approaches to funding—both from the private and public sectors.

ILCAE is recalibrating its efforts to engage businesses into the ILAgEd model while continuing ongoing advocacy efforts which was the origin of our group and the line item. We believe that increasing agriculture teacher salaries commensurate with industry is one step to addressing the critical shortage of teachers and retention efforts. This is being addressed by pending legislation-- SB2975. Through conversations with policy makers and legislators this year, it is clear that the traditional line item is unlikely to grow much under its current model. Illinois's budget situation prevents it. So, we are trying to build a model to seek business investment into ILAgEd's stakeholders. While this may not be new per se, but the approach of impact investing is certainly more focused than general fundraising. This will be ongoing and require a shift away from a culture of "giving" to one of "investing." Also, we are in early stages planning what increased public funding might look like and how that could be sustainable—that is, with some sort of private matching mechanism. The state needs to invest more, but if Illinois is truly going to be reform focused—whether willingly or not—then we within industry will need to be part of the solution rather than simply lobbying for extra funds. This is where our business engagement and advocacy efforts converge.

The result over the long-term should be more agriculture programs, more students in agriculture courses, better career-readiness for industry, and a more robust Illinois economy. One in four jobs in Illinois depends on our efforts—as does the future of our youth. ILCAE is proud to be leading efforts to address these concerns and seeks your help. Please consider nominating top talent from industry you may know to be part of our board and also provide input in our ongoing efforts.

### **Overview:**

The Illinois General Assembly spent the bulk of April and May discussing and debating the Fiscal Year 2016 and Fiscal Year 2017 budgets. Unfortunately, the General Assembly adjourned on May 31, 2016 without a budget in place. However, on a brighter note, the IAVAT's legislative initiative passed the Senate unanimously and passed the House with 111 votes. Senate Bill 2975 is now expected to be sent to the Governor for his signature. The following legislative update will discuss the background of the current budget impasse, the state of the current budget impasse, how the current budget impasse affect's Ag Education in Illinois, and provides an overview of the activity related to Senate Bill 2975.

#### **Illinois Budget Impasse Background:**

As background, it should be repeated that Illinois has not had a full fiscal year budget enacted since the Fiscal Year 2015 budget which expired nearly a year ago. However, approximately 90% of the budget items are mandated to be paid through consent decrees, regardless of if a budget is in place or not. Thus, the State of Illinois is still functioning on some level despite the fact that there is a budget impasse.

Nonetheless, the mandated spending though consent decrees does not include funding for K-12 education, public universities and community colleges, or social services. Many public universities have experienced layoffs and some social service agencies have closed altogether. The General Assembly passed a stop gap budget for public universities and community colleges in April. However, Chicago State University, Eastern Illinois University, and Western Illinois University have all experienced layoffs and may still face closure in the future.

#### Where Does the Current Budget Impasse Stand?

The Illinois House Democrats passed a proposed spending plan in late May, Senate Bill 2048, which would have appropriated spending for the entire 2017 Fiscal Year. The House Democrats noted at the time of passage of their measure that their proposal would still need revenues to fund the spending plan, but that K-12 schools, public universities, and social service networks were in need of some budgetary certainty for Fiscal Year 2017. The Governor and Republican caucuses were critical

In this same time frame, the four legislative leaders and the Governor also discussed a six month or "stop gap" budget proposal. The Governor initially opposed a six month budget, but then later advocated for a "stop gap" budget. However, the language for a six month budget was not introduced until the final evening of legislative session by the Governor and two Republican caucus leaders. The bills were introduced as Senate Bills 3434 and 3435 and House Bills 6583 and 6585 respectively.

Due to the last minute nature of the bill introductions, there was not the time necessary to discuss the fine point details of a six month budget on the final night of legislative session. The Senate took up the full year spending plan in an attempt to keep the aforementioned schools and social service agencies open. However, the measure was defeated with 17 voting Yes, 31 voting No, and 10 voting Present.

The Senate then passed a stand-alone K-12 funding bill, House Bill 2990, which would have funded Illinois K-12 schools at approximately \$900 Million. The Republican caucuses were again critical of the spending plan because it did not contain a defined revenue source. However, the measure failed in the House with 24 voting Yes, 92 voting No, and 0 voting Present.

Therefore, at present the State of Illinois is without a Fiscal Year 2016 or Fiscal Year 2017 budget. The Governor has spent time in several parts of the State in the last few days campaigning for a six month budget. However, it is not clear at this point if all the parties involved can agree on the contents of a six month budget. The General Assembly will remain in continuous session and will return to Springfield on June 8th.

#### How Does The Budget Impasse Affect Ag Education?

The current K-12 budget will remain in effect through June 30, 2016. The Governor and General Assembly would then have to vote on a K-12 budget or a full budget and send the proposal to the Governor for consideration prior to schools opening in August.

There is hope that one of these outcomes will occur as the Governor did sign a K-12 budget for Fiscal Year 2016. In addition, the Ag Ed Line Item is funded at \$1.8 million in all of the budget bills mentioned above. Thus, it is likely that the Ag Ed Line Item would be funded in a K-12 budget or a final budget compromise.

#### Senate Bill 2975 Passes Both Chambers

Senate Bill 2975, sponsored by Senator Bill Cunningham (D-Chicago) and

Representative Jerry Costello (D-Smithton), received bipartisan support in both chambers. The bill had 6 co-sponsors in the Senate and 35 co-sponsors in the House. Senate Bill 2975 passed on a vote of 58-0-0 in the Senate and 111-1-0 in the House.

The bill creates a grant program which school districts may use to assist with the cost of extended contracts for Ag education teachers. The bill also designates Ag Education as an area of critical need. We will continue to work with the General Assembly and Governor's Office to find a funding source for the grant program as all sides work towards a compromise on the budget.

Thank you to all those attend committee hearings, called your legislators, sent an email, or attend Ag Legislative Day. All your hard work paid off on the Ag Ed Line Item as well as Senate Bill 2975.

#### <u>A Look Ahead</u>

We will continue to update you as budget discussions continue in Springfield. We are also looking forward to the annual FFA convention. Please remember to invite your legislators to your Section Fairs, volunteer events, and SAE visits. Summer outreach while legislators are back in their districts can yield big benefits when legislators return to the capitol. I attended the ICAE committee meeting at the Farm Bureau Youth Conference. There were some suggestions made by the committee members at this meeting. Unfortunately, results on these suggestions are not available for the June Conference. The committee was required to have the answers to a few more questions about quality indicators for the IFGA to Jess by June 6' 2016. These results will not be available until next summer at IAVAT conference.

One big issue that we think all agriculture programs in the state should be thinking about is the availability of students to take online agriculture courses. It was really a split decision on how and when these are used in a curriculum, but the general consensus would be that these courses should also be taught under the direct supervision of a certified agriculture instructor. With the state of the budget for school districts in Illinois, we would hate to see agriculture instructors being replaced by online programs in order to save money for local school districts. These online programs really need to be a supplement to the existing program and not a stand-alone instructional method for the students in Illinois classrooms.

# Illinois State University Spring 2016 End of Year IAVAT Report

Agricultural Education at Illinois State University had a good year and continues to have an excellent group of students enrolled and preparing for a career in the field of teaching Agriculture. Below are some key points and highlights of the program.

#### Enrollment

We continued to see some growth, with 10 students entering the Ag Education program in the fall. Once again several have changed majors in and out of Ag Education, with the net result being there are currently 29 students in the teacher licensure program.

Recruiting efforts remain a priorty focus, Interest levels and initial contact with freshmen and transfer students are good, so we feel we may have another good group coming in next fall. We are trying to identify students in HS and maintain contact as they attend community colleges.

#### **Student Teachers**

We had six student teachers in the spring of 2016. We currently have two students planning to student teach in fall of 2016 and four in the spring 2017. We currently have 9 slated to ST fall of 17 and spring 18.

We have a strong track record with placement of Student Teachers highlighted below.

- Three of six student teachers for Spring of 16 have accepted teaching positions and one is looking.
- Fifty-Six percent of the teachers graduated in the last five years continue to teach.
- Just under half of the teachers graduated in the last 10 years continue to teach.

#### Current curriculum.

The curriculum remains unchanged, the major is agriculture with 10 sequences (Agribusiness, Agronomy Management, Plant and Soil Science, Agricultural Education (teacher licensure), Ag Communication and Leadership, Animal Science, Animal Industry Management, Pre-Vet, Horticulture and Food Industry Management). The MS in Agriculture has three sequences, Ag Science, Ag Business, and Ag Education and Leadership.

#### **Collegiate FFA and PAS**

Participation in our student organization was again very strong, both in terms of dues paying members, and more importantly ACTIVE members. We started the year with 34 members and the majority of them have been very active. Among the activities the CFFA/PAS participated in and/or hosted are:

- National FFA convention.
- IAVAT bus tour
- Fall and Spring PAS conferences,
- National PAS conference in Kansas City.
- Hosted a state-wide Invitational Ag Communications CDE
- Hosted the State Parliamentary Procedure CDE.
- Assisted at the Autumnal festival

- Will have a booth at the National FFA Convention
- Elite Conference
- Had a booth at the Farm Bureau Youth Leadership Conference
- ISU faculty and/or Agriculture Ambassadors visited *eight* community colleges and a number of high schools.

The 2015-16 academic year has held many challenges and successes for the Agricultural Education Program at Southern Illinois University. Summer, 2014 found SIU with six students majoring in Agricultural Education. This year saw our numbers swell to 35 Ag Ed majors, with another 20 students listed for fall semester; giving a total of 55 Ag Ed majors for 2016-17.

We are extremely grateful for the many dedicated Ag Ed teachers who have opened their programs for clinical sites and student teaching. To mention a few...

In 2015-16, the Advisory Committee continued to address challenges and opportunities for the SIUC Ag Ed Program. During this past academic year the program had one tenure track faculty, Dr. Seburn L. Pense, and one non-tenure track instructor, Dr. Chris Clemons. However, Dr. Clemons has just accepted a tenure-track position at Auburn University in Alabama for 2016-17. Thus, the coming year will see the SIUC Ag Ed Program operate with one faculty member and one Ph.D. graduate Assistant.

Howard Heavner is one year into his Ph.D. Program, and is presently serving as graduate assistant and advisor to the SIU Collegiate FFA Chapter. In addition to his Ph.D. studies, Howard will also take over the instruction of two courses; Introduction to Ag Education, and Introduction to Agricultural Technologies.

Under the state grant, GAST, the program also employed nine undergraduate interns for the purpose of recruitment, retention, curriculum design and FFA activities. In these internships, the following students made critical contributions to SIU's Ag Ed mission:

#### Master's Degree Program

Congratulations to Elizabeth Rost, Monticello agriculture teacher, and Jared Boyert, Blackhawk Community College instructor, both of whom graduated in May with a Master of Science degree in Agricultural Leadership and Science Education through the online graduate degree program. Congratulations also to our on-campus teacher licensure students who earned a Master of Science degree – Brett Kneeskern and Jacalyn Meisner.

At this time, there are approximately 30 graduate students in the program – 40% on-campus and 60% online. The program continues to offer the "try it before you buy it" option with graduate courses. You are allowed to complete up to 12 credit hours of graduate degree credit before applying to either the online or on-campus programs. Any courses completed before acceptance into the program will be applied retroactively after enrolling. As a special note of consideration, the online courses are cheaper than on-campus tuition (nearly a 40% savings). Graduate courses offered in Fall '16 include: Foundations of Agriculture and Extension Education (AGED 400); Curriculum Design and Instruction (AGED 420); and Youth Development Programs (AGED 430).

Thank you to FCAE for providing funding for teachers to receive free graduate degree credit in two courses this academic year. Teachers enrolled in the Beginning Agriculture Teachers Course (3 credit hours; Fall '15 and Spring '16) and the CDE Course (2 credit hours; Summer '16) earned free graduate course credit, courtesy of FCAE funding. Thanks also goes to the instructors for the CDE Course – Doug Anderson, Mike White, Toni Gabriel, and Bryan Schullian. Similar to last year, the program continues to offer graduate degree credit for teachers who complete the CASE Institute at Pontiac High School.

#### **Scholarships**

Dean Jason Emmert diligently strives to find ways to provide scholarships for College of ACES students and, in particular, Agricultural Education students. In previous years, state officers, section officers, and state proficiency award winners have been offered renewable scholarships. Last year, agricultural education students reported receiving \$92,650 of scholarship funding from the University of Illinois College of ACES, which is an average of \$2,807 per student enrolled in the program. Furthermore, students reported receiving \$109,500 from outside scholarships sources, which is an average of \$3,318 per student. All combined, agricultural education students earned more than \$200,000 in scholarships, which is an average of over \$6,000 per student.

#### FFA Greenhand Conference: Sept. 21

The FFA Greenhand Conference will be held Wednesday, September 21st. Collegiate FFA members and Agricultural Education students will coordinate details and design the workshops. Similar to last year, the conference will be for Greenhands only (no Student Leader portion). Registration details will be sent via listserve in August.

#### **Research Conferences and Presentations**

A majority of the Agricultural Education faculty are participating the North American Colleges and Teachers of Agriculture (NACTA) Conference this week. In addition to many other conferences attended by UIUC faculty in the United States and worldwide, faculty and graduate students have also attended the American Association for Agriculture Education (AAAE) Conference in Kansas City, Missouri, and the North Central AAAE Conference in Minnesota.

The faculty continues to welcome suggestions for improvement. Please share your suggestions with anyone from the Ag Ed team on ways to better prepare future agriculture educators and FFA advisors.

# **2016** Western Illinois University's Agricultural Education Report

The program continues to prosper and graduates continue to secure employment in the teaching profession. The program (1999-2016) has established an 83% placement rate (62 out of 75) with a 68% retention rate (42 out of 62) among our graduates still teaching. For the last five years (2011-2016), the program has established a 89% placement rate (17 out of 19) with an 76% retention rate (13 out of 17) among our graduates still teaching. Students continue their professional growth and achieve milestones in their degree programs. Here is a short list of their accomplishments for the 15-16 year.

#### JUNE 30, 2015 AND 2014

#### 1. SUMMARY OF OPERATIONS AND SIGNIFICANT ACCOUNTING POLICIES

*Summary of Operations* – Illinois Association of Vocational Agriculture Teachers (the "Association") is an Illinois non-profit corporation. Its mission is to assume and maintain an active state leadership in the promotion and furtherance of all levels of agricultural education.

The Association's headquarters are in Springfield, Illinois. Its activities are conducted throughout Illinois and are supported through membership dues, program activity fees, and sponsorships.

#### Significant Accounting Policies -

**Basis of Accounting** - The Association prepares its financial statements using the cash basis of accounting which is a special purpose accounting framework other than accounting principles generally accepted in the United State of America. This framework differs from generally accepted accounting principles primarily because the Association does not recognize receivables for dues and other revenues, accounts payable to vendors, or other liabilities, and their related effects on the change in net assets.

Under the cash basis of accounting; financial transactions are recorded when the cash transaction occurs, irrespective of when revenue is earned or expense obligations are incurred.

*Reclassification* – Certain prior year balances have been reclassified to conform to the current year presentation.

Use of Estimates - The Association uses no estimates in the preparation of the financial statements.

*Cash and Cash Equivalents* – The Association considers all liquid investments with an original maturity of three months or less when purchased to be cash equivalents. Carrying amounts of cash are at cost.

*Income taxes* – The Association is a not-for-profit organization exempt from income taxes under Section 501(c)(6) of the United States Internal Revenue Code and similar provisions of state law. The Association is classified as an entity that is not a private foundation within the meaning of Section 509(a) of the Internal Revenue Code.

The Association evaluates how the tax effects of an uncertain tax position taken or expected to be taken in the Association's tax filings should be recorded and disclosed, in the financial statement. Under its criteria the Association may recognize the benefit of a tax position only if the tax position is morelikely-than-not to be sustained upon its challenge by a taxing authority. The assessment of the tax position is based solely on the technical merits of the position, without regard to the likelihood that the tax position may be challenged. The Association's primary tax position relates to its status as a not-forprofit entity exempt from income taxes. Management has evaluated the tax positions reflected in the Association's tax filings and does not believe that any material uncertain tax positions exist.

The Association's tax filings for the years ending June 30, 2014, 2013, 2012, and 2011 are subject to examination by the Internal Revenue Service, generally for three years after they are filed.

#### JUNE 30, 2015 AND 2014

**Basis of Presentation** – Net assets are classified into one of three classes of net assets based on the existence or absence of donor-imposed restrictions. The following is a description of each class:

- Unrestricted Net Assets Unrestricted net assets includes all net assets which are neither temporarily nor permanently restricted.
- Temporarily Restricted Net Assets Temporarily restricted net assets includes contributed net assets for which donor-imposed time and purpose restrictions have not been met and the ultimate purpose of the contribution is not permanently restricted.
- Permanently Restricted Net Assets Permanently restricted net assets includes contributed net assets which require, by donor restriction, that the corpus be invested in perpetuity and only the income be made available for program operations in accordance with donor restrictions.

The Association did not have any permanently or temporarily restricted net assets during the years ended June 30, 2015 and 2014.

# 2. RELATED PARTY TRANSACTIONS

The Association is affiliated with the IAVAT Administrative Fund. They are considered to be a related party, as they share some common directors. The Administrative Fund provides services to the Association related to personnel. Fees paid to the IAVAT Administrative Fund for the years ended June 30, 2015 and 2014, were \$71,250 and \$68,777, respectively.

# 3. SUBSEQUENT EVENTS

Subsequent events have been evaluated through February 10, 2016, which is the date the financial statements were available to be issued. Subsequent events have not been evaluated past that date.
