Commentary

A major focus of this month has been working with districts on their IFG Amendments and working with schools to be able to take advantage of the FY19 3 Circle Grant. All visits in the past month have included discussions with teachers and administrators on the benefits of this grant and assisting them in overcoming obstacles that kept them from signing up this past year. It was also important to check in with those 19 teachers that were able to participate and see if they had any issues and were planning to stay involved with the grant. April also saw a few different workshops with the Ag Ed Students at the University of Illinois. Working with the juniors, we focused on how to develop leadership within an agriculture program, from freshmen through senior year. Visiting with the senior class, we focused on what to do once they had secured a job. A lot of great questions about extended contracts, stipends and the 3 Circle Grant were addressed during the class. This month we also saw the second group to compete in the Agricultural Education CDE. This year there were nearly double the participants as last year. My hope is that we can start looking at having district gualifiers, so that more students are able to participate and teach their lessons.
